The inconvenience is Accordingly, the circular bearing no.54120-570/Accts/2008-09 dt.28.07.2008 is modified as per direction of the Ld. District & Sessions Judge, Delhi, to the following extent:-

All landline telephone bills with respect to official telephone installed at the residence of Judicial Officer shall be accepted by the Accounts Branch, if bill is within their entitlement. The entitlement is as follows:-

If a bill is in excess of entitlement, the excess charges shall be first deposited with the Cash Branch in Room no.4, Tis Hazari Courts, at b. least 10 days before due date of payment of bill. Thereafter the bill shall be submitted with the cash receipt of excess payment and the remaining payment shall be paid by the Office.

If excess amount is not deposited by the Officer within 10 days before due date, the Officer himself/herself shall pay the entire amount and

then claim reimbursement as per rules.

In case the bill is not paid by the Officer and consequently the disconnection resulted then reconnection charges or other charges d. related to reconnection shall be paid by the Officer concerned. Officers who have not cleared their outstanding amount, their bill shall neither be accepted nor reimbursed till clearance of outstanding amount.
